## PREAMBLE:

On the basis of Preamble order as described, as per the 1994, Rajiv Gandhi University of Health Sciences under rule 45(5)has ordered K.L.E.College of Pharmacy, Nipani to Start M.Pharmacy (Pharmaceutics & Pharmacology) course with an intake limiting 06 (Six) seats each, from the academic year 2010-11 on the following terms & conditions.

- 1) To obtain permission from the All India Council for Technical Education regarding the management.
- 2) To obtain permission from the Rajiv Gandhi University of Health Sciences.
- 3) The institution has to follow the recent rules of the government regarding the seat sharing in the admission.
- 4) The terms & conditions laid by Rajiv Gandhi University of Health Sciences & All India Council for Technical Education should strictly & compulsorily be followed.
- 5) The directions & orders of the state government are also to be compulsorily followed.
- 6) The government of Karnataka will not give any kind of grant or financial assistance to these colleges. They are governed purely under unaided rules.
- 7) As per the granted seats 50% are reserved for the government.
- 8) If any of the above rules of the government are violated the grant / permission will be taken back.
